- *No application (even with late fee) will be accepted one week prior to the assessment.
- *Directors must be current members of MENC in order for their students to participate in State Solo & Ensemble Assessment.
- *You may send a school check or a signed PO with registration; students will not be allowed to perform until fees are paid.
- *Bring a completed *State Ensemble Adjudication Form F4.3* or *State Vocal Solo Adjudication Form F4.4* for each soloist and ensemble to the registration desk at State Solo & Ensemble Performance Assessment, and one original copy of each piece of music with measures numbered for the adjudicator.
- *Accompanists must have original music, as well. NO PHOTOCOPIES.
