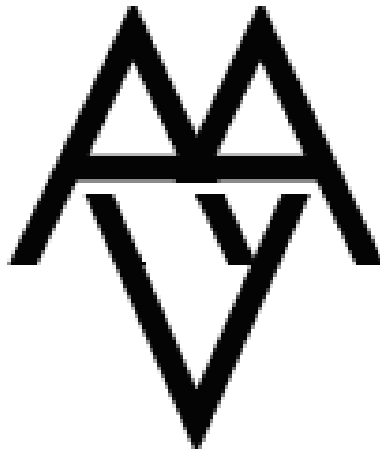

Students will not be allowed to perform/audition until fees are paid. ALL SCHOOLS WITH A SCHEDULED TIME FOR AN EVENT MUST PAY FOR THAT EVENT. No application will be accepted later than one week prior to each event, even if accompanied by late fee.
